

Video Password Authorization Request Form

Although we've implemented maximum level security measures to protect against unauthorized access to the Great New Beginnings, Inc. camera system, you as parents and guardians have the responsibility of protecting your Usernames and Passwords. Remember, you're GNBKIDS Usernames and Passwords provide unique identifiers that enable our system to identify authorized users. Therefore, your login information is the first line of defense against unauthorized access. As concerned parents and users of the GNBKIDS system, it is your responsibility to maintain exclusive control and use of your Username and Password and protect it from inadvertent disclosure to others. **YOU SHOULD NEVER GIVE YOUR PASSWORD TO ANYONE. Any video broadcast from Great New Beginnings is private media and it may not be saved, re-distributed or re-transmitted in any manner.**

Usernames should be between 4 and 8 characters, all letters should be lowercase, and logins must be unique; although your username can use any combination of letters, numbers, and special characters, do not include spaces in your username. For example, the following are examples of adequate usernames: 'jpayne', 'ywqo875', 'e_rbert'.

Strong passwords can prevent someone from assuming your identity and accessing information. **Passwords should be between 6 and 8 eight characters** with a combination of uppercase, lowercase, numeric and special characters. Below are some guidelines for creating a secure password:

- Don't choose a password associated with you in any way (middle initial, maiden name, pet's name, child's name, etc.)
- Don't choose words that can be found in any dictionary, whether English or any language
- Don't reverse the spelling of a dictionary word
- Use an acronym from an easy to remember phrase ('!A stitch in time saves nine!' can translate to (ASITS9)
- Make your Passwords 8 characters long
- Use a mixture of letters, numbers and special characters. Example: *JaFe90+
